Dear Mr. Wellnitz:

On February 8th, 2024, bids were received for three (3) trade packages with a total of Four (4) individual bids received. The bid opening followed legal advertisement for bids on January 23rd, and again on January 30th, 2024. A pre-bid meeting on January 26th, 2024, and issuance of electronic invitations to bid from Frederick Quinn Corporation to over 50 trade contractors. No bids were received for one (1) bid package, FQC will re-bid this package. The purpose of this letter is to provide a summary of the bids received and to recommend the award of trade contracts of two bid packages, BP# 3-07a Air Barriers and BP#3-08a Doors, Frames & Hardware.

The attached bid tabulations detail the bids as read at bid opening. Subsequent to the receipt of bids, scope review meetings were held with the apparent low bidders by FQC. FQC is recommending the award of trade contracts to the low responsive and responsible bidder, following a review of the bids submitted. The award recommendations are as follows:

- Bid Package #3-07a Air Barriers: Two (2) bids were received. Rasco Mason Contractors of Grayslake, IL., was the low as read bidder and is recommended as the low responsive and responsible bidder. There are no irregularities with the bid presented. We recommend that BP #3-07a be awarded to Rasco Mason Contractor, for the base bid award amount of Sixty-Five Thousand Dollars (\$65,000.00).
- 2. Bid Package #3-08a -Doors, Frames & Hardware: Two (2) bids were received. Block Iron & Supply Company of Oshkosh, WI was the low as read bidder and is recommended as the low responsive and responsible bidder. There are no irregularities with the bid presented. We recommend that BP#3-08a be awarded to Block Iron & Supply Company for the base bid amount of One Hundred Twelve Thousand Six Hundred Ninety Dollars (\$112,690.00).

After reviewing of these bids received, and approval of award recommendations, FQC will prepare a GMP amendment to finalize the project costs. The above awards will be incorporated into that amendment.
