DUE APPLICATION having been made to the Town of Beloit by the Applicant, the Town of Beloit does hereby issue this RECREATIONAL ACTIVITY PERMIT to the Applicant upon the following terms and conditions:

TERMS AND CONDITIONS

1. That the Applicant agrees and acknowledges that the event or activity to be held is a "Recreational Activity" under, pursuant and as defined in S. 895.52 Wis. Stats..
2. That the Applicant, its agents, members and participants do hereby agree to waive any claim of or for liability of any kind or nature whatsoever against the Town of Beloit, its agents, officers and employees.
3. That the Applicant agrees to save and hold the Town of Beloit harmless, as well as to protect and indemnify the Town of Beloit, its agents, officers and employees, from any claim of any kind or nature by anyone arising out of the event or activity which is the subject of this permit.
4. That the Applicant agrees to reimburse the Town of Beloit for any damages or costs incurred by the Town of Beloit including, without limitation, costs, expenses, disbursements or attorney's fees which may arise out of or be caused by the event or activity which is the subject of this permit.
5. That the Applicant, if required by officials of the Town of Beloit will provide to the Town of Beloit a policy of liability insurance upon terms and with limits acceptable to the Town of Beloit which shall name the Town of Beloit as an additional insured under said liability insurance policy.
6. That there shall be no sale, consumption or possession of intoxicating liquors, fermented malt beverages or wine on the property which is the subject of this permit unless this permit specifically designates in said permit that the sale, consumption or possession of such alcoholic beverages is permitted at the time of the activity or event.
